DESIGN RULES

1. Contest open to Nacogdoches County Students only, grades 8 - 12.
2. **Novice** exhibitors will be given a scenario and create a design based on that scenario. No points will be awarded for any design created which does not use the assigned design style. **Advanced exhibitors will create an original design based on knowledge of design principles.**
3. Exhibitors will compete as Novice or Advance Classes, **Novice** team of 3 and **Advanced team of 2** the design will constitute a sole effort with no outside assistance.
4. Each team will be required to bring their own set of tools (knife, stem cutters, and wire cutters) for their use only; exhibitors will not be allowed to share tools. **Advanced Teams must also bring a container and foam to create the teams' floral design.**
5. Exhibitors will have one hour in which to complete their arrangements. Upon completion each exhibitor must clean up their area and leave the design area.
6. No talking will be allowed during the construction of the design between teams.
7. No cell phones will be allowed in the design area during the construction of the design unless instructed. Exhibitors will be allowed to take pictures after the completion of judging.
8. Only exhibitors and show officials will be allowed in the design area during the competition.
9. Judging forms will be returned to the exhibitors Ag Science instructor or County Extension Agent after awards have been announced. Any score resulting in a tie will be decided by the Judge.
10. Any exhibitor found in violation of the rules will result in disqualification.
