RULES & REGULATIONS

- 1) This show is open to all residents of East Texas.
- 2) All entries must be in clean, polished STANDARD MASON glass canning jars. **Two piece lids must be scaled and free from rust and corrosion. All entries must be processed by water, steam or pressure canned.** Entries not compliant with these standards will not be allowed in competition. **All entries will be opened for tasting.**
- 3) Jars must be clearly labeled with the name of the product and the exhibitor's name, address, and phone number before they are accepted into the competition.
- 4) All entries must have been completed by the Exhibitor within twelve (12) months prior to the Piney Woods Fair.
- 5) Three (3) entries may be made in each category per exhibitor.
- 6) Judges may award a 1st Place in a category even if the category has no other entries for competition in that category. In the event of a tie, the Judges decision is final.
- 7) All entries will be discarded after judging.

-- AWARDS --

First (1st) through Third (3rd) Place ribbons will be awarded in Junior and Senior Divisions of each category.

Participation Ribbons will be awarded for Junior Division only.

Best of Show Rosettes will be awarded in Junior, Senior, and Adult Divisions

The point system is as follows: Blue Ribbon = 3 points, Red Ribbon = 2 points, White Ribbon = 1 point,

Best of Category = 2 points.

Fair shall not be liable to Exhibitor lost profit or other financial loss to Exhibitor of any type or description including any special, indirect, incidental, or consequential damages (including but not limited to detrimental reliance damages) which may be caused directly or indirectly by the enforcement of Fair rules. Fair and Exhibitor agree that Exhibitor shall protect, indemnify and hold harmless the Fair from any and all claims, suits and/or judgments (including costs incurred in defending any such claims, suits, or judgments) brought by anyone as a result of any loss, damage, or injury to any person, animal, or property occasioned by and/or as a result of inaction of Exhibitor, either solely or in conjunction with Fair or anyone else.
